POLICING 2026

Policing 2026 is a collaborative and strategic programme of work being driven by the SPA and Police Scotland that aims to transform the police service incrementally over the next 10 years.

The strategy provides the opportunity to achieve long term sustainability and our vision of 'sustained excellence in service and protection'. It will also clearly set out why we need to change, what we are trying to achieve and how we will do it.

It will ensure Police Scotland is sufficiently flexible to address new and changing demands to improve outcomes for people, communities and places.

Ultimately, Policing 2026 will empower all of us to develop effective partnerships, innovate, solve problems, and continue to protect the public from harm.

What will change?

Our focus will be on improving the effect of our policing services and working more intelligently with partners and the public to deliver better outcomes for individuals and communities.

Despite a changing world, our values of Fairness, Integrity and Respect will remain constant.

We will focus on five areas:

1. **Prevention:** Tackling crime, inequality and chronic issues.
2. **Protection:** Based on threat, risk and harm.
3. **Communities:** Focus on location and diversity in the virtual world.
4. **Knowledge:** Informing the development of better services.
5. **Innovation:** Dynamic, adaptable and sustainable.

What Happens Next

We now need to hear from you. Over the coming weeks we will be finalising the detailed plans for the implementation of Policing 2026. It is vital that everyone has the opportunity to have their say in the development of this important strategy.

CALLS AND CRIMES REPORTED

Between 1st February 2017 and 28th February 2017 there were **234** (278 for Jan) calls recorded by Police Scotland relating to the Rosyth area.

During the same period there were **15** (20 for Jan) detected crime files on the system with a further **26** (21 for Jan) crime files still being investigated and **2** (3 for Jan) vehicle documentation offences.

Reminder in respect of Dog Fouling Procedures

IF THE IDENTITY OF THE DOG WALKER IS KNOWN – Contact Fife Council Contact centre to report dog fouling on 03451 55 00 22 or email

Environmental.Enforcement@fife.gov.uk. The information required is date, time, identity of owner and dog and place of offence. Please leave your contact details so the Enforcement Officer can get in touch with you. You will then be contacted by an Environmental Enforcement Officer who will note a brief statement that you will be required to sign. A letter from the complainer is sufficient if the complainer can identify the owner of the dog, to allow a fixed penalty notice to be issued. The fine for this offence is £40.00, increasing if it is not paid within the required timescale.

IF THE IDENTITY OF THE DOG WALKER IS NOT KNOWN – Contact Dog Warden with time, date and full description of walker and dog. Any particular pattern of the walker for example the time that they walk and route they take is important to allow Environmental Enforcement Officers to observe and hopefully trace the offenders.”
